

Dallas-Ft. Worth Chapter Meet

The Texas Chapter of the NCRS will host a Chapter Meet on Saturday, May 7th, 2016 at Dave and Chuck Anderson's shop, Automotive Performance Unlimited, in Fort Worth, TX. The address is:

Automotive Performance Unlimited is located in southwest Ft. Worth, just north of Rt. 20. To get there from the east, take Rt. 20 and go west through downtown Ft. Worth. Pass Rt 35W, and then bear onto Rt 183 N at the Hulen Mall. Make a left onto W Vickery Blvd, and take it until you get to Automotive Performance Unlimited. From the north, take Rt 35W South through downtown Ft Worth. Make a right onto Rt 20 W, and bear onto Rt 183 N at the Hulen Mall. Make a left onto West Vickery Blvd and follow the road until you get to Automotive Performance Unlimited.

Flight Judging will be limited to 4 cars (one C4 or C5). A 5th car may be approved by the Event Judging Chairman if a sufficient number of judges are registered for the event. There is no limit on the number of Sportsman Display cars.

Important rules regarding car judging requests: We anticipate a greater number of car judging requests than the number of judging slots available. Because of that, we will need to enforce the following:

1. Car judging requests will be approved on a first come, first served basis beginning Tuesday March 1st at 8:00PM.

2. Car judging requests must be entered into the NCRS online registration system, insurance & proof of ownership documents properly uploaded, and judging fee payment completed to be considered for approval.

3. One judging slot will be reserved for the event host (if applicable).

4. One car judging request per NCRS member (as stated in the Judging Reference Manual for Chapter events).

5. Cars that have not been Flight judged previously will be given priority unless Chapter judging is needed to satisfy a requirement for the Founders award.

6. NCRS members requesting Flight judging should be Texas Chapter members in good standing.

7. If a 5th Flight judging entry is approved by the Event Judging Chairman, a lottery will be held from the car judging requests that have been wait-listed. Date of the lottery will be determined and announced if necessary.

All cars registered for the DFW Chapter Meet will be positioned on the judging field at 9:00 AM. A Judges meeting will be held at 9:00 AM followed by an Owners meeting at 9:10 AM. Ops check judging will begin immediately following the Owners meeting. *Note:* The cold start check will be waived for this meet. All Cars must remain on the judging field until released at 3:00 PM on Saturday.

In order to have sufficient judges to make this event a success, we may require that anyone entering a car in the event serve as a judge. Chapter members not entering a car in the meet are urged to judge. Realizing that some of you may be a novice judge, our intent is to pair you with a more experienced judge. Judges will earn two points for this event.

There will be a sign-in sheet at the NCRS display that should be signed by all Texas Chapter members. Please drive a Corvette to the event in order to help satisfy the Top Flight Chapter Award requirement.
