**REGISTRATION AND JUDGING INFORMATION:** It is required that you provide proof of ownership and valid proof of liability insurance for the vehicle being entered in this event with THIS registration and again at the event. All Corvettes for Flight Judging, Performance Verification, Founders, Bowtie, McClellan, and Special Interest Display cars will be parked inside and must be pre-registered. Sportsman cars must be pre-registered and will be parked inside on a space available basis. All cars must be in designated place by 5:30 PM, Thursday October 15th. All registered cars inside must remain on display in their designated place until after the Judging completed. Each Flight division is limited and admittance will be based on date of application and when payment is received. A single car may not be entered for multiple activities at the same event. You cannot enter a car for Flight Judging and Sportsman or Performance Verification and Sportsman, etc. Cars registered for Sportsman, Bowtie, Duntov or Special Interest Display will not be judged. Pre-registrations will be accepted only if premarked on or before Oct. 1, 2009. Mailed pre-registrations will not be accepted after Oct. 1, 2009. Registrations after Oct. 1 must be sent by e-mail to Tim Ehlers (tbl@ehlers.com) with payment and late fee of \$75 being made at the Convention Center. Admittance to any NCRS function will be allowed only with proper name tag. All NCRS members must be registered and you may not attend solely as a guest. *(Security & Secured parking for all registered cars and trailers paid will be available Thursday, Friday and Saturday nights, 6PM – 6AM).*
